They are well-established and active persons who have a strong affinity towards the community and have dedicated themselves to serving society through our Kannada Vaishya Welfare Trust.


We warmly welcome them to our fold. Their inclusion in the Trust has strengthened our hands and we hope to incorporate more activities with their help and support.

ASSISTANCE PROVIDED TO A NEEDY FAMILY

During the course of our survey of affected families at the time of the Covid-19 pandemic, we came across a distinctive family of two blind brothers who lived with their mother in Choundgeri village, near Gokarna.

The aged mother of 70 years was the sole provider and caretaker of the family. With a very limited land holding and a dilapidated house, the family was in a constant crisis, especially at the time of the pandemic. During the rainy season, the situation was very desperate, with a leaking roof and dampness prevailing in and around the house for several months.

Our Kannada Vaishya Welfare Trust had provided them with grocery kits twice during the lockdown period, addressing one part of their problem. In the Trust's novel initiative of "Support a Family" scheme, this family was supported by Shri Girish Sitaram Gokarn, of Mumbai, for an entire year. Food, clothing and medicine expenses were borne by the donor from July 2020 to June 2021.

Our KVW Trust thought of providing a permanent solution to their housing problem, which was not an easy task. The property was undivided and hence could not be utilized for any construction activity. Their related family members were convinced to partition the land so that this poor family could get a decent shelter.

After the land issue was resolved, necessary permissions were obtained from the local authorities for building a house. The Gram Panchayat also released funds from the Govt. scheme to help in the construction. Individual donors and other social service organizations fully supported the brothers in their endeavor to build a new home.





Tragedy struck when the mother expired shortly after the second wave of the pandemic, leaving the brothers truly helpless. However, local families helped them to cope with the loss and provided them with food and care.

The resolute will power of the blind brothers won over many well-wishers and the dream of creating a suitable abode for them began to fructify at a very fast pace.

Many donors offered to provide construction materials, while some helped with cash donations. Within a few months, the building structure was complete and the finishing work was undertaken.

On the part of the Trust, Shri K.V.Shetti, President – KVWT, undertook the general supervision, and visited the building site several times.

Some of our Trustees and other donors contributed towards the construction and finishing work through the Trust.

SUPPORT A FAMILY SCHEME UNDER OUR COMMUNITY OUTREACH PROGRAM

One of the big initiatives, which the Trust has undertaken, is the "Support a Family" project wherein around 20 poor & deserving families are supported by patrons from various parts of the world. The Trust has developed its own mechanism for providing assistance in procuring food, clothing and medicines for the beneficiary families. The scheme is actively monitored and all the records are meticulously maintained.

Based on the reports of beneficiaries and donors published by KVWT from time to time, many community brethren have expressed keen interest to support such families, financially and otherwise. The Trust will identify and publish details of such families, patrons can choose the

family they are willing to support and inform the Trust accordingly. The Trust in turn will accept donations on behalf of the families and fulfill the stipulated requirements.

We had announced the second phase of the project via WhatsApp on 13th Oct. 2021 requesting donors to sponsor 10 needy families @Rs.20,000 per family per year. Within a span of 3 hours, community members came forward to adopt all the 10 families. We were truly humbled by their prompt and kind gesture. As the response was overwhelming, we decided to include some more deserving families in the list. The final list has 23 beneficiary families supported by donors from India and abroad.

INCLUSION OF OUR COMMUNITY IN E.W.S. QUOTA

OUR SAMAJ STUDENTS CAN NOW GET E.W.S. CERTIFICATES

We are happy to inform you that the eligible students of our Kannada Vaishya Samaj can now obtain EWS certificates. The Karnataka State Govt. has issued a fresh G.O. vide Himvaka/75/BCA/2019 dt. 31-07-2022.

In our previous issue of SPANDANA – Vol. I, Issue 03, we had narrated about the efforts put in by our leaders and progress made in securing the EWS benefit as on Dec. 2020. From Dec. 2020 till July 2021, we intensified our efforts and put pressure on the State Govt. with the help of District-in-Charge Minister Shri Shivaram Hebbar, Speaker of Legislative Assembly Shri Vishweshwar Hegde Kageri, Minister for Backward Classes Shri Kota Srinivas Poojary, Revenue Minister R.Ashok, MLAs Shri Vedavyasa Kamath, Shri Dinakar Shetti, Smt. Roopal Naik, etc. Our efforts bore fruits with the Karnataka Cabinet approving the proposal on 22-07-2022 and subsequent issue of fresh G.O. on 31-07-2021.

We thank all Kannada Vaishya Sanghas, Mahila Mandals and Youth Wings of our Samaj, all well-wishers and our community brethren for supporting and actively participating in our struggle for obtaining the E.W.S. benefit. Our sincere thanks to Shri Shivaram Hebbar, Shri Vishweshwar Hegde Kageri, Shri Kota Srinivas Poojary, MLC Shri D.S.Arun, Shri D.H.Shankar Murthy, MLAs – Shri Dinakar Shetti and Smt. Roopali Naik.

Students / Job seekers of our community are advised to take advantage of this facility, obtain EWS Certificate and appear for more and more competitive exams to reach better prospects in education and employment.

A Brief Note on E.W.S. (Economically Weaker Section) quota and its advantages.

Many of our students, job seekers, families of our community are unaware of E.W.S., eligibility criteria and its advantages. Please do take some time to know more about E.W.S.

The Govt. of India has made the 103rd Constitutional Amendment and provided a maximum of 10 percent reservation to candidates from Economically Weaker Sections with effect from 01-02-2019 by making suitable modifications to Article 15(6) Admission to Educational Institutes and Article 16 (6) Civil Services. The G.O. to this effect was issued vide PAUSHA 22 1940 (SAKA) dt. 12-01-2019.

Eligibility for obtaining EWS certificates is as below.

- 2. The candidate should not belong to any caste, which is listed as SC/ST or OBC by Govt. of India as per memo dated 31-01-2019.
- 3. The income of the family of the candidate should be less than Rs.8,00,000 per annum.
- 4. They should not possess the following:
 - a) 5 acres of agriculture land and above.
 - b) Residential flat of 1000 sq. ft. and above.
 - c) Residential plot of 100 sq. yards and above in notified municipalities.
 - d) Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

Where these certificates are useful -

- 1. For admission and jobs in educational institutes run by Central Govt. like Kendriya Vidyalayas, Central Universities. etc.
- 2. For Central Govt. employment like IAS/ IFS/ IRS, Railways, Dept. of Post, Income Tax Dept., etc.
- 3. For recruitment in Public Sector banks like SBI, Canara Bank, Bank of Baroda, etc.

Who issues EWS certificates

The students should apply to Tahsildars of their jurisdiction with required documents. The Tahsildar will issue the certificate within 21 days and the certificate will be valid for one year from the date of issue.

PROGRESS MADE IN OUR DEMAND FOR INCLUSION IN OBC CATEGORY

The Backward Classes Welfare Dept, DC Office, Karwar, vide their letter BCW / HimVaAa / Jatiserpade / CR / 2021-22 dt. 16-08-2021 had invited applications from communities/ castes with miniscule population for being considered to be included in Other Backward Classes [OBC] category.

This matter was discussed in various forums of our Samaj. In response to the above referred letter, UKVS Hubli, convened an online meeting of well-wishers and representatives of Kannada Vaishya Samaj on 03-09-2021 and discussed elaborately about submitting the application on behalf of our Samaj. In the meeting, it was agreed that the representation should be submitted through Kannada Vaishya Vidyanidhi and all other organisations of our Samaj should support Vidyanidhi in all respects.

On 06-09-2021, representation was submitted to Uttar Kannada DC Office with a request to include our Kannada Vaishya Samaj in OBC category of Karnataka State. The representatives of Vidyanidhi, Kannada Vaishya Welfare Trust and representatives of Kannada Vaishya Sanghas from Karwar, Hubli, Ankola Dharwad and other places were present on this occasion.

On 22-01-2022, the delegates of our Samaj led by Shri K. V.Shetti President of KVWT and Shri G.G.Shetti of K.V. Vidyanidhi met the President of Karnataka Backward Classes Commission, Shri K. Jayaprakash Hegde in Honnavar and requested him to consider our application favourably.

During the meeting, Shri K.V.Shetti and our Samaj leaders explained about the history, tradition, customs, the hardships of our traditional profession, economic backwardness, population, etc. were thoroughly explained to the President. The President of the Commission asked us to attend the Public Enquiry before the Commission at Bengaluru after receiving the letter from them.

On 04-03-2022, our Samaj delegates attended the Public Enquiry conducted by the Backward Classes Commission. President Shri Jayaprakash Hegde and other members of the Commission were present. We presented our case. The officials of the Commission asked several questions in connection with our Samaj, the documentary evidence, our food habits, traditional vocation / professions, population, etc.

We replied their questions satisfactorily and requested them to include our Samaj in the 2A category of OBC.

On 28-03-2022, we once visited again the office of the Commission to know the progress. Some additional information was sought.

On 31-03-2022, we visited Bengaluru and submitted one more letter providing the supplementary information and highlighted our specific request to include our community in category 2A. The Commission informed us that they would visit our places for spot inspection.

We have also initiated a survey of our Samaj in selected villages to collect more data. Since then, we have been proactively following up the matter. We request all the Kannada Vaishya Samaja bandhavas to assist us and support us until we get the Government Order.

What is the difference between EWS and OBC?

- EWS is the 10 percent reservation within General Merit given to economically weaker sections and at present useful only for Central Govt. jobs and admission to educational institutes run by the Central Govt.
- In Karnataka, at present, the EWS certificate is not useful for State Govt. jobs or educational institutes.
- Our Kannada Vaishya Welfare Trust has taken the lead and we had applied for OBC reservation in Sept 2021. The matter is being and constantly followed up at various levels.
- At present, our Samaj has not yet been included in the OBC category in Karnataka State.

Some advantages / benefits to our Samaj if we are included in OBC Category

- Poor and meritorious students will get scholarship from Primary, High School and College levels.
- Reservation in admission in Education Institutions.
- Concession in fees for appearing for competitive examinations.
- Relaxation in upper age limit for competitive exams.
- Subsidy, loan at concessional rates for establishing new business/industry.
- Reservation for contesting in local body elections.
- Other advantages as per the State Govt. schemes / projects announced from time to time.
- Special coaching for appearing the competitive exams.
