PROFILE OF RECEIPIENTS OF KANNADA VAISHYA VIJAYA RATNA AWARDS - 2022



Dr. Sadanand Ramakrishna Shetti was born on 06-02-1936 at Gokarn. His father, Shri Ramakrishna Shetti, and mother, Smt. Saraswati, were both teachers. He finished his schooling at P. M. High School, Ankola. He completed his BA (Hons.) from Sharana Basaveshwara College, Gulbarga, securing the first rank.

He completed his M.A., M.Lib.Sci. & Ph.D. from Karnatak University, Dharwad, with top grades. Later on, he secured his L.L.B. degree as well.

Initially, he started his career in the Indian Postal Service, where he worked for 11 years. He started working as an Assistant Librarian at Karnatak University, Dharwad, from 1967 onwards. After 28 years of service, he retired in the year 1995.

In addition to his position in the Karnatak University, he worked as a Visiting Professor of Ancient History in the same University. He also served as Principal of Lingayat Education Society's Library Science Certification Course.

During his service and even after retirement, he has been guiding the youth in the field of personality development and competitive examinations.


Dr. Sadanand Shetti loves reading and writing in his spare time. He is a good orator and has delivered numerous speeches at various events and programs.

Over the years, he has been felicitated number of times by reputed NGO's and other organizations for his service to the youth and the community. He has been presented with notable awards such as Kadambotsav Award, Vidya Ratna Award, Raja Ram Mohan Roy Foundation Award, Sharada Shalmala Award, Indira Gandhi Priyadarshini Award, etc.

Shri Anant Subray Shinganmakki, born on 06-01-1939 at Ankola, received his high school education at the People's Multipurpose High School, started by the eminent Dr. Dinkar Desai. Getting a college education was not an easy task in those days.

With a desire to study further but hampered by poverty, young Anant, with God's will and the blessings of his elders, got admission in Bhumareddi Engineering College, Hubli, and started studying to be an engineer.

After completing 2 years, he obtained admission in an engineering college in Mumbai where he graduated with a Diploma in Mechanical Engineering. Later, he completed Post Graduation in Automobile Engineering & PG in Factory Management course by his own efforts.

On 03rd Jan. 1962, he started working as a Transmission Engineer in Premier Automobiles Ltd., Mumbai. In 1971, he joined Ideal Java India Pvt. Ltd., Mysore, where he worked for 10 years in a high position. In 1981, he resigned from the service and started his own company - Vaishali Engineering Works in Belgaum. His company manufactures a special component – machine tools micro boring & facing head key less drill cheque – which is used all over India. He has fondly named this component as "Ankola" in remembrance of his hometown & his own humble beginnings.

In 1971, he married Uma, daughter of Mr. Vitthal Ganesh Shetty, a prominent business-man of Dharwad. Smt. Uma, a BA graduate, is also humble like him. Her contribution in the success & achievements of her husband is immense. Their, son Shri Rajesh, daughters Mrs. Chandrika & Mrs. Vaishali are all engineers like their father. Both the daughters are married and living in USA. His son, Rajesh, is looking after his father's factory at Belgaum. Rajesh's wife, Smt. Sarika, is working as Tahsildar in Belgaum. Their son, Chi. Aditya (10th Std.), is a Badminton enthusiast, champion of the Belgaum Badminton tournament and has also obtained State ranking in Badminton.

Shri Anant Shinganmakki has served as Member & Secretary of Mumbai Kannada Vaishya Sangha, and organized many cultural events during his tenure. He was one of those instrumental in uniting the Mumbai Sangha and Mazgaon Sangha when they were functioning separately. Now, he is actively working in Belgaum Sangha and many other organizations. The Kannada Vaishya Welfare Trust has decided to award him the Kannada Vaishya Vijaya Ratna Award in recognition of his work ethics, perseverance and devotion to duty.

Dr. (Prof.) NAGARAJ P SHETTI - for achievement in Scientific Research



Dr. Nagaraj Pundalik Shetti is an Associate Professor at School of Advanced Sciences, KLE Technological University, Hubballi. He has 16 years of experience in academia, teaching & research. He has guided & is guiding numerous research scholars for Ph.D. His research expertise & interests are nanomaterials for hydrogen production, sensors, biosensors, and photo catalysis. He has published 170 research, 45 review articles in reputed international journals & 18 book chapters with an h-index of 56 & citations of 8025. He was selected as Vocational Training Team Member (2016) by Rotary International to study dairy products & manufacturing in California, USA. He has received Outstanding Contribution in Reviewing Award 2019 from Vacuum Journal, Elsevier, Netherlands. He worked as a Visiting Professor in Dept. of Chemistry & Biochemistry, Lamar University,

Texas, USA, 2018. Currently, he is the Associate Editor of Frontiers in Energy Research, Materials Science for Energy Technologies & Sensors International. He also serves as a member on the editorial board of Electrochemical Science Advances. He is the reviewer for more than 100 scientific international journals. He ranks among the World's Top 2% Scientists in the 2020 list of outstanding researchers prepared by Elsevier BV, Stanford University, USA. The Govt. of Karnataka has presented Shri Nagaraj Shetti with Shri C V Raman State Award for Young Scientists in the field of Chemical Sciences for the year 2021. This award was given in March 2023.

Dr. MILIND SHETTI - for Service in Health & Medical Field

Dr. Milind Shetti is a Consultant Radiation Oncologist in HCG NMR Cancer Center, Hubli. He completed Schooling & College from Dharwad and MBBS from S.Nijalingappa Medical College, Bagalkot. He did his M.D. in Radiation Oncology from M.S.Ramaiah Medical College, Bangalore. He trained under a renowned Radiation Oncologist from India and worked in KCTRI, Navanagar, Hubli. After he moved to Kolhapur, HCG recalled him to Hubli. Dr. Milind has 8 yrs. of post PG experience post & has treated thousands of patients till date. His wife, Dr. Prajna KS is an Asst. Professor, Dept. of Pathology, Basaveshwar Medical College, Chitradurga. She completed her MBBS & MD degree from A.J.Institute of Medical Sciences, Mangalore. She has trained in Advanced Onco-Pathology and manages the blood bank & laboratory in the hospital.

SUPPORT A FAMILY SCHEME UNDER OUR COMMUNITY OUTREACH PROGRAM

Since 2016, our Kannada Vaishya Welfare Trust has been steadfastly working for the community. Many progressive activities and schemes have been organized especially for the benefit of the weaker section of our community.

The Covid-19 situation and subsequent lockdowns affected everyone. People of our Kannada Vaishya community also faced problems like disruptions of cash flow, loss of income, shortage of food materials & daily essentials, etc.

During the Covid-19 period, our Trust provided essential items (consisting of rice, cereals, lentils, groceries, vegetables, etc.) to more than 150 poor and needy families of the Kannada Vaishya community twice in a span of 4 months. All this was possible by the generous donations from philanthropic minded people of our community. We express our gratitude to them.

After observing many families who were struggling to make ends meet, our Trust initiated a novel project, "Support a Family Scheme". This scheme, started in 2019, was aimed at supporting an entire family by providing them with financial assistance to procure, food, medicines and clothes for one full year. An amount of Rs.20,000 was earmarked for each family.

When we first posted the details of the scheme in our WhatsApp groups, the response we got was amazing. Within a span of a few days, numerous sponsors came forward to adopt the 20 beneficiary families. Food stuff, medicines and cloth materials were procured from designated shops in their taluka. The designated shop owners cooperated by promptly supplying the beneficiaries with the essential materials. The beneficiary families were extremely joyful and even the sponsors were pleased with the working of the scheme. The scheme was monitored regularly by our Trust and all the records were meticulously maintained.

The beneficiary families have conveyed their gratitude and blessings to the donors every time we met them.

Seeing the success of the first project, this scheme was continued in the year 2020-2021 also. This time, 23 families were identified for receiving the benefits. Much credit is to be given to all the philanthropic minded community members, some of whom have contributed to the scheme continuously for two years.

We are pleased to say that this "Support a Family Scheme" initiated by our Trust has been a success story right from day one.

We had announced the third phase of the project via WhatsApp on 5th Jan. 2023 requesting donors to sponsor needy families @Rs.20,000 per family per year. Within a few days, community members came forward to adopt the identified families. We are truly humbled by their prompt and kind gesture. This year, a total number of 20 beneficiary families are being supported by donors from India and abroad.

We are thankful to all the designated shops from where the beneficiary families obtain the materials every month – Shri Vijay Ganesh Shetti of M/s Narasimha Super Shoppe, Ankola, Shri Subhash Shivanand Shetti of M/s Durga Krupa Cloth Stores, Ankola, M/s Nayak Medicals, Ankola, Shri Chandrakant Shetti of M/s Mahalasa Enterprises, Bankikodla, and many others have been actively involved in distributing the groceries, medicines and cloth materials to the beneficiaries regularly. They are also instrumental in obtaining the feedback from the families and informing us of the working of the scheme from time to time.

We are expecting some more sponsorships from the philanthropic minded people of our community. So far, we have helped the following no. of families through this project – [2020-2021 – 16 families, 2021-2022 – 23 families, 2022-2023 – 20 families].

PROGRESS MADE IN OUR DEMAND FOR INCLUSION IN OBC CATEGORY

We are happy to share that the Govt of Karnataka has included Vaishya Vani Samaj in the OBC under category 2D vide Govt. Order Himavaka/134/BCA/2023 dt. 27-03-2023. This enables the students of our Samaj to claim reservation in jobs of Karnataka State Govt. and for pursuing education in the educational institutions run by the State Govt. Out of the total 32 percent reservation, category 2D has 7 percent. The break up figures of reservation are as under.

To avail benefits of reservation, we need income and caste certificate of Category 2D. Moreover our Samaj students have been mentioning our caste in different ways like Vaishya Vani, Hindu Vaishya, Vaishya, Kannada Vaishya, etc. We have also requested the Govt. to consider these as synonymous groups / sub groups of Vaishya Vani and issue the caste certificates. This will take some more time since there has been a change of Government in the state of Karnataka (the last assembly elections was held on $10^{\rm th}$ May 2023).

(TIME-LINE OF EVENTS)

In July 2021, the Backward Classes Commission had issued a notification and invited applications from communities having miniscule population for inclusion in the OBC category and to provide social justice to such communities by bringing them into the mainstream of the society.

On 03-09-2021, an online meeting was convened to discuss the matter. All the well wishers, office bearers of Vaishya Vidyanidhi and various Kannada Vaishya Sanghas, Trustees of KVWT attended the meeting. It was decided that a representation should be sent to the concerned Dept. of the Karnataka State Govt. requesting them to include our Samaj in the OBC category. It was also decided to send the application through Kannada Vaishya Vidyanidhi on behalf of our Samaj. All the other organizations were requested to give authorization letters to Kannada Vaishya Vidyanidhi to undertake the official correspondence with the State Govt.

On 06-09-2021, representation was given to the Uttar Kannada D.C. on behalf of our Samaj in Karwar by the President, Kannada Vaishya Vidyanidhi. Shri K.V.Shetti, President, KVWT, Shri Govind G.Shetti President Kannada Vaishya Vidyanidhi and many of our community leaders were present on this occasion.

On 04-03-2022, the Backward Classes Commission summoned representatives of our Samaj for public enquiry in Bengaluru. In the enquiry, the Board Members of the Commission asked many questions about the population, food habits, culture, the deities worshipped, the status of education, economic conditions etc. The representatives answered the questions satisfactorily. The commission informed us that they would come to our place for spot inspection. A committee "KVS committee for OBC" was formed consisting of Office Bearers & members of various KV Sanghas & well-wishers who voluntarily offered to work for securing the OBC tag. The purpose of this group is to oversee the works related to OBC, review the progress and for effective coordination. The public hearing was attended by Shri Govind G Shetti, Shri Pradeep H Shetti, Shri Sadanand R Shetti, Shri Vithal D Shetti and Shri Satish Kalmane.

On 11-04-2022, an online meeting was held and a survey format was finalised to collect the data from community members. Meanwhile, the Commission wrote letters to Mangaluru, Karnatak University Dharwad and Shivamogga University to find out whether any study was done on our Kannada Vaishya Samaj. The Universities replied that no such study was done about our community. A sample survey of our Samaj was done and the data collected from about 300 families from Ankola, Karwar and Yallapur Talukas from Apr. 2022 to Aug. 2022.

We regularly met the office bearers of the Backward Classes Commission in Bengaluru and kept providing the additional information as and when sought by them.

On 22-11-2022, we met the Chairman of the Backward Classes Commission at his office in Brahmavar, near Udupi, and had a lengthy discussion with him. He wanted to know whether there was any mention about our Samaj in the Govt. Gazetteer in the revenue records. We provided the photo-copy of some pages pertaining to our Samaj as mentioned in the British Gazetteer of 1883 of the erstwhile Bombay Province wherein a brief description about our Samaj is available under the caption - Vaishya Vani or Kannada Vani. The Chairman remarked that this is a valid evidence and that they would send the report under the title Vaishya Vani Samaj or Kannada Vani Samaj. The Backward Classes commission is reported to have submitted an interim report in Dec. 2022 including our Samaj.

On 28-12-2022, during the assembly session, Honourable Minister for Backward Classes Welfare Dept. made an historical announcement that the State Govt. has decided to include Vaishya Vani Samaj in the OBC category. Participating in the discussion, Shri Vishweshwar Hegde Kageri, Honourable Speaker of Vidhana Sabha informed the Govt. that there are many groups of Vaishyas, which are called by different names. He also advised the Govt. to identify the different Vaishya sub- castes and to include them under OBC.

On 07-01-2023, our delegates met District In-charge Minister, Shri Kota Srinivas Poojary, in Kumta, and gave an application to extend the OBC facility to our Samaj also along with the Konkani speaking Vaishya Vaani Samaj. The Minister responded positively and informed that the OBC matter would be presented in the forthcoming cabinet meeting for their approval.

On 16-01-2023, Shri K.V.Shetti, Chairman KVWT, took an appointment with Shri Vishweshwar Hegde Kageri



in Sirsi and led the delegates to meet the Hon. Speaker of Vidhana Soudha who assured us that he would try his level best to extend OBC facility to our community along with the Konkani speaking Vaishya Vani Samaj.

On 20-01-2023, our delegates met Shri Shivaram Hebbar and Shri Vishweshwar Hegde Kageri in Vidhana Sabha, Bengaluru, and requested them to get the cabinet approval for our inclusion in OBC category.

On 30-01-2023, we once again met Shri Shivaram Hebbar in Yellapur and reminded him about our issue.

On 19-02-2023, our community members met Shri Bapusaheb Anagolkar, the State President of Vaishya Vani Samaj in Belagavi. We had a lengthy discussion and we decided to work jointly to reach our goal.

On 08-03-2023, an online meeting was held with the Vaishya Vani Samaj and decision was taken on the following points –

- 1. To form a core committee and intensify our efforts to get the cabinet approval before commencement of the election code of conduct.
- 2. It was decided to meet the C.M. at the earliest.

On 12-03-2023, we met Shri Shankar Patil Munenakoppa, Cabinet Minister for Sugar & Textile and requested him to take up the matter with the Chief Minister. Later we met Shri Basavaraj Bommai, Hon. Chief Minister and requested him to take necessary steps for including our Samaj in OBC.

The Chief Minister assured us that he would do the needful. As a result of our incessant efforts and continuous follow up, the State Govt. approved the proposal in the cabinet meeting held on 24-03-2023 and included our Samaj in Category 2D in OBC. The Govt. notification to this effect was issued on 27-03-23.

We thank all the Trustees of KVWT, Directors of Kannada Vaishya Vidyanidhi, all the Kannada Vaishya Sanghas of our Samaj, well-wishers and Samaj Bandhavas of our community for their active participation and the support throughout.

We have also requested the Govt. to issue the caste & income certificates to the eligible students of our Samaj. This will take a couple of months. We request our community members to kindly wait till such time.

Regular updates on the OBC status will be provided through our KVWT WhatsApp groups.






